**RESOLUTION ACKNOWLEDGING THE REVISED MAXIMUM WEIGHT LIMITS FOR THE
JELLYS FERRY ROAD AT SACRAMENTO RIVER BRIDGE (BRIDGE NO. 08C0043), AND
DIRECTING THE DIRECTOR OF PUBLIC WORKS TO ERECT AND MAINTAIN SUITABLE
WEIGHT LIMIT SIGNS IN ACCORDANCE WITH VEHICLE CODE SECTION 35752**

WHEREAS, Vehicle Code sections 35750 et seq. authorize the California Department of Transportation, upon request of the County, to determine the maximum weight of vehicle and load for any County bridge; and

WHEREAS, the Department of Transportation has made an engineering investigation of the Jellys Ferry Road at Sacramento River Bridge (Tehama County Bridge No. 08C0043); and

WHEREAS, the Department of Transportation held a duly noticed public hearing on December 21, 2016 regarding the maximum weight limit for the Jellys Ferry Road at Sacramento River Bridge; and

WHEREAS, based upon the engineering investigation and all evidence presented at the public hearing, the Department of Transportation has determined, by written order that the maximum weight of vehicle and load which the Jellys Ferry Road at Sacramento River Bridge with safety to itself will sustain is as follows:

11 Tons per Vehicle
18 Tons per Truck and Semi-Trailer
22 Tons per Truck and Full Trailer

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Tehama that the maximum weight limits for the Jellys Ferry Road at Sacramento River Bridge, as determined by the California Department of Transportation, are hereby acknowledged, and the request for the Department to establish such weight limits, pursuant to Vehicle Code section 35751, subdivision (c), is hereby approved, confirmed, and ratified.

BE IT FURTHER RESOLVED that the Director of Public Works is hereby authorized and directed to erect and maintain suitable signs specifying the maximum weight determined by the Department of Transportation in accordance with Vehicle Code section 35752.
