PURPOSE & RESPONSIBILITIES



PURPOSE

Our purpose is to advise the Tehama County Health Services Agency's Executive Director and the Tehama County Board of Supervisors on public health issues, programs, and services affecting the health of our community.

RESPONSIBILITIES

ADVISE: Advise the Agency's Executive Director and the Tehama County Board of Supervisors on policies, goals, and operation of Public Health.

REVIEW: Review the community's needs and the adequacy of health care services, programs, access to providers, and facilities to meet those needs.

ENCOURAGE: Encourage support throughout the county for the development and implementation of effective public health programs.

ASSIST: Assist Tehama County Health Services Agency Public Health in assessing the community's health needs, prioritizing the identified needs, and proposing actions to meet identified needs.

PREPARE: Prepare an annual report of Public Health Advisory Board's activities for Public Health to present to the Tehama County Board of Supervisors.

PROVIDE: Provide advocacy with state and federal legislative bodies on health and budgetary issues affecting Tehama County.

Accomplishments

We are proud of these accomplishments over the past year.

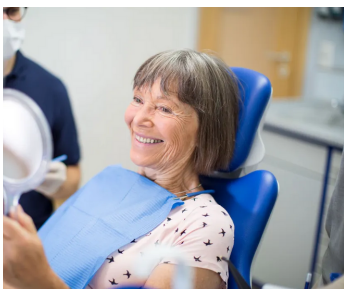
- **Successes:**
 - Once again, our collaborative partnerships assisted us in participating in multiple outreach events for children, youth, the special needs population, homeless population, parents and families in Tehama County. Conducted in-service trainings, focus-group assessments, kindergarten oral health assessments(KOHAs), implemented oral health paid media campaigns, promoted oral health literacy, and provided numerous oral health resources including toothbrush kits to our partners.
 - Community outreach events – Toothbrush kits and educational resources were distributed. Community partner clinics (Northern Valley Indian Health and Greenville Rancheria) provided screenings and fluoride varnish applications.
- **In-service trainings:**
 - TANF Tribal Family Workshops - Aug 2023 and Feb 2024
 - Kindergarten Oral Health Assessments - Nov 2023 - May 2024
 - Health Youth Tehama (HYT) meetings - Jan – June 2023
- **Building and strengthening collaborative partnerships:**
 - First year completing kindergarten oral health assessments in Corning Union Elementary school locations in partnership with Greenville Rancheria.

Improving the Oral Health of our Community

- In partnership with Registered Dental Hygienists at Greenville Rancheria and the Corning Union Elementary school district nurse, screened four schools, 265 TK - 1st grade students and provided 36 applications of fluoride varnish. Schools included West Street Elementary, Oliveview Elementary, Woodson Elementary and Rancho Tehama Elementary.
- In partnership with Northern Valley Indian Health Dental Clinic, the Children's Oral Health Outreach Coordinator screened 8 schools (42 classes). Schools included Los Molinos Elementary, Middle, Antelope Elementary, Metteer Elementary, Jackson Heights Elementary, Bidwell Elementary, Fluornoy Elementary and Kirkwood Elementary.
- In partnership with First 5, participated in a Books for Businesses campaign and provided 200 oral-health based books and educational material to dental providers, healthcare providers, restaurants and other businesses.
- In partnership with Rolling Hills Dental Clinic and the Tehama County Tobacco Education program, conducted an outreach event on 2/22/24 for "Through with the Chew," day and provided oral cancer information and smokeless tobacco quit kits.

Goals

We look forward to reaching these goals.

- Establish a school based Oral Health Program that provides access to routine oral health services including but not limited to, sealants.
- Provide support/Technical assistance (TA) to school nursing or Office of Education staff regarding inputting KOHA data into the System for Oral Health Reporting (SCOHR) State database.
- Continue to collaborate on event and clinic opportunities with the three local Indian Dental Health Clinics: Rolling Hills Dental Clinic, Greenville Rancheria Dental Clinic, Northern Valley Indian Health Dental Clinic.
- Continue to identify gaps in access to hospital dentistry services in the county for young children and identify funding sources to assist with follow up care that families cannot afford.
- Keep the Tehama County Board of Supervisors apprised of the status of oral health care accessibility for low-income individuals in our county.
- Obtain diverse dental committee membership to better address oral health-related gaps and barriers within our county.
- Accomplish the state approved Oral Health program scope of work goals and objectives.
