

**AMENDMENT #1
TO THE AGREEMENT
BETWEEN
THE COUNTY OF TEHAMA
AND
TEHAMA COUNTY DEPARTMENT OF EDUCATION**

This Amendment to Agreement #2023-126 dated April 25, 2023, by and between the County of Tehama, through its Health Services Agency (County) and the Tehama County Department of Education (Contractor) for the expanded provision of the “Club Live” and “Friday Night Live” programs, shall be amended as follows:

3. **COMPENSATION**

Contractor shall be paid an all-inclusive flat fee of \$88,073.00 per fiscal year (July-June) for all services rendered under this agreement. Contractor shall not be entitled to payment or reimbursement for any tasks or services performed except as specified herein.

Contractor shall not be paid any compensation or reimbursement beyond the flat fee amount set forth above, and Contractor agrees that County has no obligation, whatsoever, to compensate or reimburse Contractor for any expenses, direct or indirect costs, expenditures, or charges of any nature by Contractor that exceed the flat fee amount set forth above. Should Contractor receive any such payment it shall immediately notify County and shall immediately repay all such funds to County. This provision shall survive the expiration or other termination of this agreement.

It is mutually agreed that all other terms and conditions of Agreement #2023-126 shall remain in full force and effect.
