

FIRST AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT
BETWEEN
PARTNERSHIP HEALTH PLAN OF CALIFORNIA
AND
COUNTY OF TEHAMA

This is the First Amendment to the Professional Services Agreement (the “First Amendment”) between Partnership HealthPlan of California (“PARTNERSHIP” or “PLAN”) and County of Tehama doing business as Tehama County Health Services Agency, hereinafter referred to in this First Amendment as “PROVIDER”.

WHEREAS PARTNERSHIP and PROVIDER entered into a Professional Services Agreement effective January 1, 2024. The 2024 Professional Services Agreement and subsequent amendments including this First Amendment thereto are referred to as the “Agreement”.

WHEREAS PARTNERSHIP and PROVIDER now desire to amend the Agreement as set forth and to have the other terms of the Agreement remain unchanged.

NOW, THEREFORE, in consideration of the mutual promises contained herein, PARTNERSHIP and PROVIDER agree to be legally bound as follows:

1. The effective date of this First Amendment shall be May 1, 2025.
2. The Parties agree that as of the effective date of this Agreement Chiropractic Services is added to Attachment C, FQHC/RHC Compensation Physician Rates.
3. Effective May 1, 2025, Attachment B, Location(s), is deleted in its entirety and replaced with a new Attachment B, Location(s), as attached herein.
4. Effective May 1 2025, Attachment C, FQHC/RHC Compensation Physician Rates is deleted entirety and replaced with a new Attachment C, FQHC/RHC Compensation Physician Rates.
5. All other terms and provisions of the Agreement not amended hereby shall remain in full force and effect. In the event of any inconsistency between the terms of this Amendment and the Agreement, the terms of this Amendment will govern and control.
