Louise Wilkenson invited Green Waste to participate at a Lake California Board meeting and give an update on their operations.

District Manager Amanda Garrett commented that this education plan is a requirement of the contract with the County.

In response to Supervisor Hansen, Ms. Garret explained the State Law requirements regarding diversion of waste and the various categories. Ms. Garret provided further details about separating recycling.

closure on Newville Road at Kendrick Creek

Administrative Services Director Tom Provine gave an update on the Newville Road bridge and options for repair.

In response to Supervisor Walker, Mr. Provine explained the limited load rating on option 2 and explained the creek work and permitting on option 3.

John McClain gave an explanation regarding the engineering of the 3 options. Mr. McClain also provided information about option 3 being a more permanent solution until the bridge can be replaced in the Caltrans replacement program.

Louise Wilkenson asked why the State is not helping with funding this project and the upcoming bad weather, which may affect the project.

Jessica Clark commented that we did not get the funding from the State due to a preexisting condition of the bridge.

In response to Supervisor Burroughs, Mr. Provine explained that the State denied funding due to erosion issues at the bridge in previous years.

In response to Supervisor Jones, Mr. Provine clarified options for emergency services to get across the creek and the environmental requirements of building a new bridge.

Consensus was received to transfer emergency funds and backfill with Secure Rural Schools funding, move forward with option 3 and increase Purchasing Agent authority for this project.

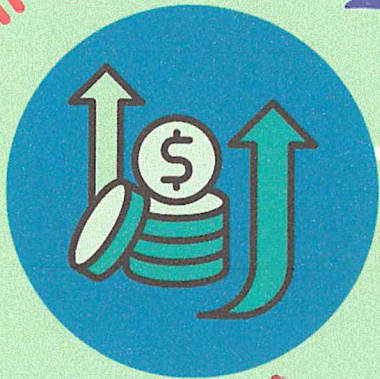

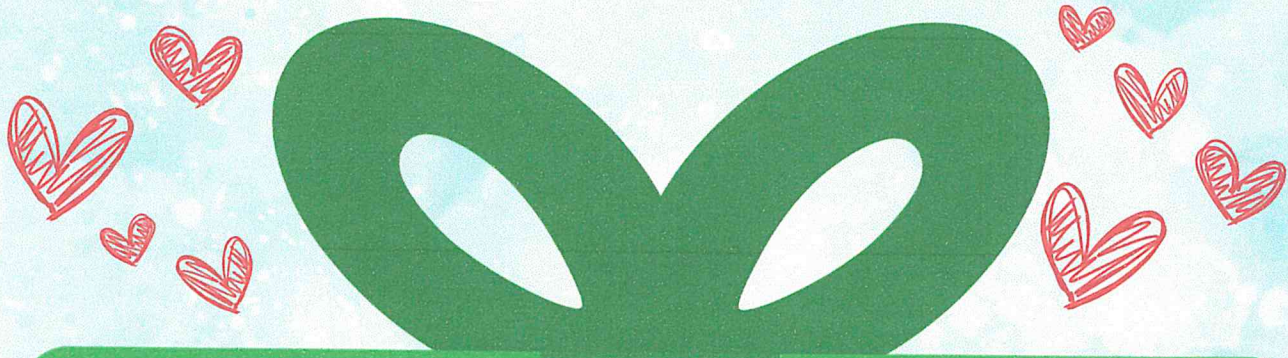

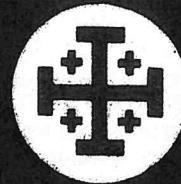

Government . . . Then we have an independent, uncontrolled and
uncoordinated government in the Federal Reserve System,
operating the money powers which are reserved to Congress by the
Constitution*".

14th Amendment Right to Equal Protection and Due Process of
Law; The Common Law requirement of Contract; Title 12 USC
152; Federal and State Land Patents; Fundamental Right to
Allodial Freehold; State Banking Laws, e.g. Wis. Stats. 134.15 and
138.01; and numerous concurring Federal and State Court decisions
on Contracts, Mortgages and "Dollars".

Whereas, only gold and silver have ever been declared to be the
"*Money of Account of the United States*" by The Coinage Act of
1792 and codified at 31 USCA 371; and States are expressly
prohibited by I:10:1 of the U.S. Constitution from making
". . . any Thing but gold and silver Coin a Tender in Payment of
Debts"; therefore, Judges are Constitutionally estopped from pro-
ceeding contrary to I:10:1 of the Constitution which they swore on
Oath to support . . . "*So help me God*". The laws are on your
side! USE THE LAW TO REDEEM YOUR PROPERTY!!!

Further, Mortgage Foreclosures are predicated on a Fiction of
Law - the artificial sign "\$" being universally understood to mean
"U.S. Dollar".

However, the current Federal Reserve Corporation "dollar" has
been reduced to a Fiction of Law by repudiation of the Standard
Unit of Value. In today's society the "dollar" is accepted by the
masses because of their residual memory of the time when the
"dollar" WAS a fixed Standard Unit of Value representing a
specific weight of gold of 12.632 grains 90% fine at 31 USC 314,
and 412.5 grains of .999 fine silver at 31 USC 316.

Presently, we are prohibited from utilizing the Standard Unit of
Value by an Act of Congress, HJR # 192 of June 5, 1933, declaring
it to be ". . . against public policy" to use gold as the "*Money of
account of the United States*" at 31 USCA 371. The final blow came
on June 24, 1968 when the U.S. Treasury abdicated its obligation to

mint silver coins by which the States could Constitutionally declare
a legal tender ". . . in Payment of Debts" at I:10:1, and in the
"*Money of account of the United States*" at 31 USCA 371.

Subsequent to repudiation of gold in 1933, and silver in 1968, the
cumulative consequences was that CONGRESS ELIMINATED
THE "*MONEY OF ACCOUNT OF THE UNITED STATES*" (31
USCA 371) FROM THE NATION'S BANKING SYSTEM . . .
WITHOUT DECLARING A REPLACEMENT!!! The astonishing
results are that neither our Courts nor Public Offices are complying
with the Federal Statutes at 31 USCA 371; nor the U.S. Constitu-
tion at I:10:1, which these same judges and public servants are
sworn on Oath to support . . . "*So help me God*".

More informed Christians are challenging the Court's jurisdic-
tion to make an arbitrary determination of a "dollar liability"
against them and contrary to I:10:1 of the U.S. Constitution;
especially since no Standard Unit of Value predicated on gold or
silver exists since 1968 for the Court to base its claim for "dollars"
upon!

While Federal Reserve Bank notes (FRNS) may be denominated
in dollars or units, that does NOT make FRNS a "Dollar" in the
"*Money of account of the United States*" at 31 USCA 371.

Even though FRNS are codified as "*tender for debts*" at 31 USC
392; the code does NOT make FRNS a "*Payment of Debts*" at
I:10:1; and Courts are Constitutionally estopped by I:10:1 from
declaring FRNS to be "*payment*" in lieu of gold and silver coin;
contrary code (31 USC 392) claims notwithstanding!

Judges shall take Judicial Notice they are sworn on Oath to
support the Constitution at I:10:1, and NOT contravening codes as
31 USC 392 which may NOT supercede the . . . "*Supreme Law of
the Land*" at Art. VI, Cl. 1.

But you ask . . . "Who else did it?" A fair question deserves a
fair answer. Several precedent cases are won and others pending
across the Nation. (Don't expect the "free press" to tell you!) More
victims of the privately-owned Federal Reserve Banking cartel are
learning to protect their Fundamental Rights to Allodial Freehold
and redeem their property from the stranglehold of the 20th
Century Money Changers!

On April 2, 1979, dairy farmer Richard Kauffman of Loyal,
Wisconsin, sued FHA agents for obtaining mortgage claim to his
farm by fraud. The U.S. attorneys came to FHA agents' defense
claiming ". . . they were only doing their job" - but these same
U.S. attorneys were at a loss to explain how FHA agents were
". . . only doing their job"; - OBTAINING A MORTGAGE BY
FRAUD . . . contrary to Federal Statutes at 31 USCA 371; U.S.
Constitution at I:10:1; State Banking Laws 134.15 and 138.01; The
Common Law; and voluminous concurring Court decisions which
indicate otherwise!

Farmer Kauffman cut-off payments pending adjudication of
Fraud Charges in Court. It is nearly three years and U.S. attorneys
have NOT been able to answer the Fraud Charges; consequently,
Farmer Kauffman has legally "discharged" a \$90,000 FHA
Mortgage; and GOT PAID TO DO IT . . . LEGALLY!!!

HOW MANY FARMERS, BUSINESSMEN, AND HOME-
OWNERS ARE STILL STRUGGLING TO "KEEP UP THE
PAYMENTS ON A MORTGAGE OR NOTE THAT WAS AC-

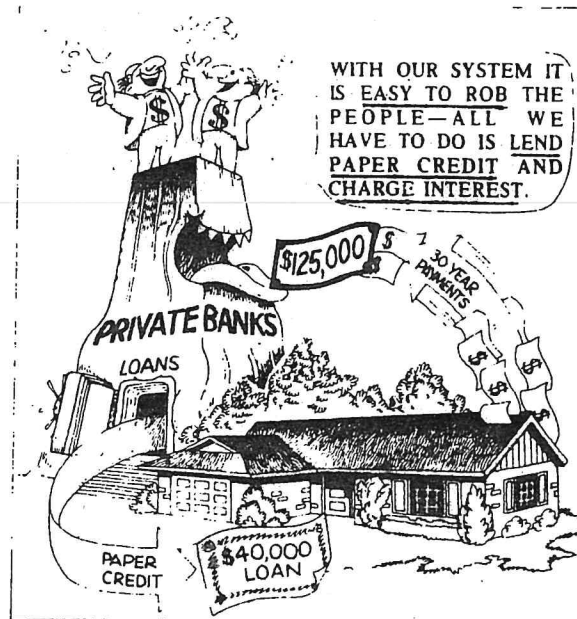

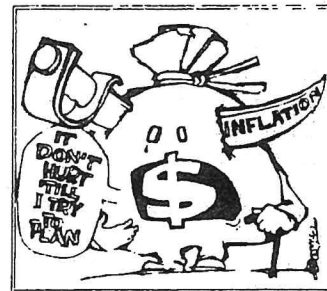
Federal Reserve Note isn't a 'Dollar'
