BEFORE THE TEHAMA COUNTY AIR POLLUTION CONTROL DISTRICT BOARD OF DIRECTORS APPROVE THE NORTHERN SACRAMENTO VALLEY PLANNING AREA 2018 AIR QUALITY ATTAINMENT PLAN REQUIRED BY THE CALIFORNIA CLEAN AIR ACT

WHEREAS, California Health & Safety Code, Section 40925, requires any District which is nonattainment for the State ozone standard, on or before December 31, 1994, and at least once every three (3) years thereafter, to review and revise its attainment plan to correct for deficiencies in meeting the interim measures of progress incorporated into the plan pursuant to Section 40914; and

WHEREAS, the entire Northern Sacramento Valley Air Basin ("NSVAB"), which includes the Tehama County Air Pollution Control District ("TCAPCD"), was designated nonattainment for the state ambient air quality standards for ozone on June 9, 1989, by the California Air Resources Board ("CARB"); and

WHEREAS, the TCAPCD continues to be designated as a "moderate" non-attainment area for the state ambient air quality standards for ozone with respect to Attainment Plan requirements found in Section 40918 of the California Health & Safety Code; and

WHEREAS, the Sacramento Valley Basinwide Control Council (BCC) endorsed the 2024 Attainment Plan update on October 4, 2024 and includes an overview, air quality monitoring data and results for the past three (3) years for the NSVPA, public education progress, transport of pollutants and the District's status of feasible control measures; and

WHEREAS, the 2024 Plan update includes new control measures to be considered for existing rules in Table IV-1 and new control measures to be considered for basin-wide model rule development in Table IV-2; and

WHEREAS, each of the NSVPA districts (Butte, Colusa, Feather River (Yuba and Sutter), Glenn, Shasta, and Tehama) are required to approve the 2024 Plan update pursuant to California Health and Safety Code Section 40925.

THEREFORE, BE IT RESOLVED, that the Tehama County Air Pollution Control District Board of Directors hereby adopts the Northern Sacramento Valley Planning Area 2024 Triennial Air Quality Attainment Plan update.
