WHEREAS, effective in 2025 the California Legislature passed, and the Governor approved Senate Bill 1100 amending Chapter 887, Section 12940 of the Government Code relating to discrimination; and

CODE RELATING TO DISCRIMINATION

DECOLUTION NO

WHEREAS, Section 12940 declares it is an unlawful employment practice, unless based upon a bona fide occupational qualification, or, except where based upon applicable security regulations established by the United States or the State of California; and

WHEREAS, Section 12940(q)(1) declares it is unlawful for an employer to include a statement in a job advertisement, posting, application, or other material that an applicant must have a driver's license unless both of the following conditions are satisfied: (a) the employer reasonably expects driving to be one of the job functions for the position, and (b) the employer reasonably believes that satisfying the job function described in paragraph (1) using an alternative form of transportation would not be comparable in travel time or cost to the employer; and

WHEREAS, Section 12940(q)(2) declares that for purposes of this subdivision, "alternative form of transportation" includes, but is not limited to, all of the following: (a) using a ride hailing service; (b) using a taxi; (c) carpooling; (d) bicycling; (e) walking; and

WHEREAS, classifications which require a valid California Driver's License upon hire are outlined in Exhibit A of this document shall be revised to state: "Possession of, or ability to obtain and maintain, a valid California Class C driver's license and a satisfactory driving record is required. Individuals who do not meet this requirement due to a disability will be reviewed on a case-by-case basis."; and

WHEREAS, classifications not requiring a valid California Driver's License upon hire and not listed in Exhibit B of this document shall be revised to state: "A valid California Class C driver's license or alternative form of transportation may be required for some positions at the time of appointment. Individuals who do not meet this requirement due to a disability will be reviewed on a case-by-case basis."; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Tehama, the implementation of the provisions of Section 12940(q)(1) and Section 12940(q)(2) of Senate Bill 1100 of the Government Code will be applied to all classification specifications in Tehama County as required.
