**ESTABLISHING THE COMPENSATION FOR THE UNREPRESENTED POSITION OF
DISTRICT ATTORNEY INVESTIGATOR I / II - EXTRA HELP WITHIN THE MEMORANDUM
OF UNDERSTANDING BETWEEN TEHAMA COUNTY AND THE TEHAMA COUNTY PEACE
OFFICERS ASSOCIATION**

WHEREAS, the Board of Supervisors of the County of Tehama, State of California, desires to employ persons to carry out the duties and responsibilities of the classification of District Attorney Investigator I / II – Extra Help; and

WHEREAS, IT IS THE DESIRE OF THE Board of Supervisors to provide certain benefits, to establish certain conditions of employment and to set working conditions for said employees; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Tehama, State of California, does hereby establish the terms and conditions of employment for the unrepresented employees designated in this resolution to be the same as described in the Memorandum of Understanding between the County of Tehama and the Tehama County Peace Officers Association;

BE IT FURTHER RESOLVED that the unrepresented employees designated in this resolution are exempt from the following Articles: Recognition, Management Rights, Association Rights, Security, Concerted Activities, Grievance Procedure, Industrial Leave (except 9.2, 9.3, 9.4, 9.7, 9.8, 9.9, 9.10), Employee Status, Wages and Classifications (except 11.1), Hours and Overtime (except 12.1, 12.2), Promotion/Lateral Transfer, Demotion and Layoff, 15.6, 15.7, 15.8, 15.10, Sick Leave (except 17.2 and 17.3), Holidays, Vacations, Uniforms, 22.3, 22.4, Miscellaneous, Employee Benefit Program, Group Insurance, Effect of Memorandum of Understanding, Emergency Provision, Entire Agreement, Term of the above referenced Memorandum of Understanding and any successor provision.

BE IT FURTHER RESOLVED that the employees designated in this resolution will serve at the will and pleasure of the District Attorney.

BE IT FURTHER RESOLVED that the hourly wage for the position of District Attorney Investigator I / II – Extra Help shall be as follows:
