RESOLUTION NO. ______ A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF TEHAMA ADOPTING THE BUDGET FOR FISCAL YEAR 2025-26

WHEREAS, The Board of Supervisors of the County of Tehama, having discussed the annual County Budget items separately and having heretofore fixed and determined the various items as required by law; And the County Auditor having filed the Recommended Budget and the Notice of Hearing for the Adopted Budget having been published according to law; And

WHEREAS, said 2025-26 Adopted Budget, as depicted on Schedule 2, contains a total appropriation, including transfers out, of \$274,273,120 and provisions for new or increased obligated fund balance (reserves) of \$4,999,817 for a total requirement of \$279,272,940 with financing of: Estimated revenues, including transfers in, of \$263,569,128, and use of fund balance and reserves of \$15,703,811 for a total means of financing of \$279,272,940.

NOW, THEREFORE BE IT RESOLVED, that the Board of Supervisors of the County of Tehama adopt and establish the Adopted Budget for fiscal year 2025-26 as set forth in the Adopted Budget document of the County of Tehama, State of California, for the year ending June 30, 2026 with the contents of said booklet, a copy which is filed in the office of the County Clerk, to be incorporated into and made part of this Resolution, as provided for in Section 29090 of the Government Code of the State of California, known as Exhibit "A".

AND WHEREAS, certain monies having been appropriated in fiscal year 2024-25 for purchase orders, service agreements and contracts; And the purchase, service or contract remain to be completed; And the funds necessary to fulfill these obligations having been encumbered and set aside as outlined on Schedule 3 of the proposed Adopted Budget of 2025-26,

NOW, THEREFORE BE IT FURTHER RESOLVED, that the encumbered funds be added to the Adopted Budget and made available for fulfilling the obligations for which they were appropriated as necessary in the 2024-25 fiscal year.
