Background Information:

Below is a list of bills the Agency has supported and where they currently stand.

AB 762 (Irwin and Wilson) - Disposable (single-use) Vape Ban

This bill would ban the sale of disposable (single-use) vapes in California to address toxic waste and fire hazards from lithium-ion batteries. The bill was amended to be a two-year bill and recently passed the Assembly Appropriations Committee on January 22, 2026 with an 11-4 vote. The bill passed the Assembly with a vote of 46-15 on January 29, 2026, and is now headed to the Senate.

SB 501 (Allen) - Responsible Battery Recycling Act of 2022: covered batteries

This bill was amended to no longer apply to all household hazardous waste (HHW) and instead to fix an issue with another law, the Responsible Battery Recycling Act of 2022. That law excluded batteries weighing over 5 kilograms or 300 watt-hours from the definition of a covered battery. The bill would remove the exclusions from the definition of a covered battery for a primary battery and a rechargeable battery and categorize all covered batteries as either a small format battery or a medium format battery. This bill would instead require the stewardship plan to describe how the producer or stewardship organization will provide a certain number of collection sites for small format batteries and medium format batteries, as specified. The bill recently passed the Senate Appropriations Committee on January 22, 2026 with a 5-2 vote and ordered to a third reading. Staff will continue to monitor the progress of this bill.

AB 998 (Hadwick) - Household Hazardous Waste: vape pens

This bill was amended in July to evaluate opportunities to increase safety and convenience related to the management and disposal of vape pens confiscated from students by a school. The bill was then referred to the Suspense File in August and has not been re-introduced this legislative session.

Tehama County Recycling Market Development Zone Update

Background Information:

The Agency was awarded \$42,545 in Zone Incentive Funds (ZIF) in February 2025 to promote the Tehama County Recycling Market Development Zone. With these awarded funds the Agency has been able to continue to participate in various events to promote the zone and meet the Agency's goals for FY 2024/25 and FY 2025/26. Below is a list of events that the Agency has participated in or supported using ZIF.

Red Bluff-Tehama County Chamber of Commerce Business Summit - March 13, 2025:

Sponsored the Business Summit and had a table displaying the TCRMDZ props and brochures. Interacted with over 20 attendees and gave away several brochures with additional details on the zone.

Sacramento River Discovery Center Spring and Fall Plant Festivals - May 10 and November 1, 2025:

Sponsored the Plant Festivals and had a table displaying the TCRMDZ props, brochures, and compost information. Interacted with over 25 attendees during both events and gave away several brochures on the RMDZ, backyard composting guides, and food scrap pails.

Reuse and Repair Education with the Tehama County Library - currently ongoing:

The Agency, in partnership with California Product Stewardship Council, is currently supporting the Tehama County Library to increase reuse and repair education in Tehama County. Several repair themed events have been hosted at the Red Bluff and Corning branches, and repair kits are currently available to be checked out at those branches. A bicycle repair stand installation and bicycle repair event is still being planned for later this Spring.

The SBA program was developed by Agency staff in preparation of Assembly Bill 341, known as the Mandatory Commercial Recycling law. The SBA program fosters a positive relationship between local businesses and the Agency. The SBA provides businesses with recycling options that make financial sense. Agency staff continuously encourage businesses to recycle and have promoted the program to businesses through informational flyer mailings and in-person outreach. By joining the SBA, businesses gain community recognition for their efforts. Partners appreciate the assistance in complying with the Commercial Recycling mandate.

AB 341 requires any California business that generates four or more cubic yards of commercial solid waste per week or is a multi-family dwelling of five or more units to recycle. The law requires local jurisdictions to inform their businesses, public entities, and multi-family complexes of the state mandate to recycle. The SBA program helps the Agency meet its informational requirement and generates diversion data for reporting purposes.

Christian provided indoor recycling containers to all 5 new businesses who signed up for the SBA program and provided further recycling tips through informational flyers and group presentations. Christian will continue to contact local businesses in-person and via phone and e-mail regarding AB 341 and the SBA.

Carpet Recycling Program Update

Requested Action(s)

Background Information:

In 2012, Tehama County and five other rural counties were chosen to be part of a pilot carpet recycling program. Upon implementation, the Tehama County/Red Bluff Landfill began accepting carpet and pad during normal business hours for recycling. Individuals who self-haul carpet that is segregated from the rest of their load are charged a reduced tipping fee of \$77.86 per ton as compared to \$117.73 per ton for mixed loads.

Since implementation, the Landfill had seen an overall increase in the amount of carpet being recovered for recycling until 2020. Data for 2013-2025 is broken out below:

The Agency is not exactly sure why recovered carpet tons have decreased since 2020, but there is speculation among industry professionals that installers have been switching to luxury vinyl flooring instead of carpet.

Mattress Recycling Law

Requested Action(s)

Background Information:

California's Used Mattress Recovery and Recycling Act (enacted in 2013, and amended in 2014 and 2019) requires mattress manufacturers to create a statewide recycling program for mattresses discarded in the state. The Program is funded through an \$11 recycling fee collected from consumers when a mattress or box spring is sold beginning Dec. 30, 2015. The Mattress Recycling Council (MRC) is a non-profit organization established by the mattress industry that has been certified by CalRecycle to develop and administer the Program.

Waste Connections signed an agreement with MRC for the processing of mattresses received at the Tehama County/Red Bluff Landfill. As a result of the agreement, beginning January 1, 2016, mattresses and box springs have been accepted free of charge, resulting in a significant increase in units collected for recycling.

Beginning in calendar year 2021, the Agency was able to additionally seek reimbursement for mattresses and box springs that were illegally dumped and cleaned up as part of the Agency's Illegal

Dumping and Litter Abatement Program. A total of 51 mattresses and box springs were cleaned up in 2025. The reimbursement has not yet been received.

Subject: December 2025 Monthly Update

1. I continue to provide Green Building Code compliance support to the building departments and monitor and provide support to the cities and the County for paper product procurement.
2. Christian and I attended the ribbon cutting for WM's new compost facility at their Anderson Landfill on December 3. It was a great opportunity to see what they have planned for organics collection and processing in Shasta County and connect with WM staff to discuss potential costs for hauling organics collected in Tehama County.
3. Christian met with Corning Union High School staff on December 3 to go over the Smart Business Alliance (SBA) program and learn more about the high school's current recycling program. The school board approved the application to join the SBA shortly after his meeting. A second meeting is planned for January, during which Christian will be joined by Ashlee from WM to assess their needs for recycling collection bins in the classrooms and administrative office.
4. I promoted safe sharps and medication disposal, as well as proper battery recycling at the Tehama LIFT event held at the fairgrounds on December 5. I spoke with over 34 attendees and other booth vendors, gave out 12 mail-back sharps containers, and several orange battery bags.
5. Christian participated in a recycling audit ride-along with Max from Green Waste on December 8. They engaged residents by providing recycling tips and feedback on their current practices and will meet again to review the collected data to identify opportunities to improve the program and increase diversion rates.
6. Christian attended Good Morning Red Bluff on December 11 to promote the SBA program and provide information on recycling services to local businesses and community members.

7. I virtually attended the Rural Counties' Environmental Services Joint Powers Authority (ESJPA) meeting with Tom Walker at the Agency's office on December 11. During the meeting we learned more about SB 54 and the potential impacts to rural jurisdictions, as well as receiving greater clarification on the AB 1826 exemption ending and the ESJPA's interest in lobbying CalRecycle to extend the exemption.
8. I promoted the Recycling Market Development Zone (RMDZ) program at the Tehama County Library's sewing repair class on December 11. I also gave an interview for a short video being produced to highlight the RMDZ and our partnership with the Library to encourage residents to repair their belongings before replacing them.
9. I was on vacation December 12 and December 19.
10. I attended the RMDZ ZoneWorks virtual meeting on December 16 and learned about new ways to share information and receive assistance for the RMDZ, as well as information on reporting deadlines.
11. Christian and I met with Waste Connections to review their updates to the second diversion sign and provide feedback for the final version. We also discussed the issues they were having with their previous company that had installed the first diversion sign and their plan to install the next sign using their own staff.
12. The Agency's office was closed on December 24 and December 25, while the Landfill was closed on December 25 in observance of the Christmas holiday.
13. The Agency held its monthly meeting with Waste Connections on December 30. We discussed progress on maintenance for the recycling sorting line and methane gas collection system, upcoming scale calibration, and assistance the Sheriff provided for addressing the trespassers coming onsite during the overnight hours. I also discussed plans for the HHW lockers that will be removed from the Corning facility and where they will be staged at the Red Bluff facility.
14. Agency staff contributed waste reduction, recycling and hazardous waste disposal information to the monthly Lake CA POA newsletter and WasteWise News, and produced and distributed the Educators Newsletter.
15. Household hazardous waste collection events will be held from 8:00 AM – 12:00 PM on the second Saturday of January in Red Bluff. I am currently working on setting up a meeting with ACTenviro to discuss increasing the event frequency in Red Bluff.
