

**3rd AMENDED LEGAL SERVICES AGREEMENT BETWEEN
THE COUNTY OF TEHAMA AND PRENTICE|LONG, PC**

WHEREAS, a Contract was entered into on July 27, 2021 ("Contract") by and between the COUNTY OF Tehama ("County"), and Prentice Long, PC ("Contractor"), and amended twice to provide legal and investigative services and

WHEREAS, the Contract provides for a termination date of July 31, 2023; and

WHEREAS, the parties wish to increase the scope of the agreement to include providing qualified non-attorney consultation for the Health Services Agency's Mental Health Division; and

WHEREAS, in addition, the not to exceed limit of this contract shall be increased by \$100,000 for the purpose of providing these qualified non-attorney consultation services to the Health Services Agency's Mental Health Division. For the avoidance of confusion, this additional \$100,000 shall only be available for the use towards the qualified non-attorney consultation services contemplated by the instant amendment; and

WHEREAS, Contractor has qualified personnel with the appropriate level of education and experience to provide consulting to the Health Services Agency's Mental Health Division on a project basis; and

THEREFORE, the parties wish to add the following to Attachment A and B.

 - Monitors developments related to behavioral health matters; evaluates their impact upon County operations and recommends and implements policy and procedural improvements
 - Complies with continuing education requirements, in accordance with the licensing board if applicable.


