**AMENDMENT #1  
TO THE AGREEMENT  
BETWEEN  
THE COUNTY OF TEHAMA  
AND  
WIPFLI, LLP**

This Amendment #1 to Agreement #270PA25, dated July 1, 2025, by and between the County of Tehama, through its Health Services Agency (County) and WIPFLI, LLP (Contractor) for the provision of providing consulting services for the County, shall be amended as follows:

Contractor Name Change: WIPFLI, LLP is assigning its rights and interests in the contract to legal entity “ WIPFLI Advisory LLC.” All references to WIPFLI, LLP and/or Contractor in Agreement #270PA25 shall hereafter be deemed to refer to WIPFLI Advisory LLC.

Section 3, “Compensation,” shall be replaced with the following paragraph:

3. **COMPENSATION**

Contractor shall be paid \$7,500.00 for the Medicare Cost Report, \$4,500.00 for the Medical PPS Reconciliation Request, \$8,500.00 for the Change in Scope of Service Request (CSOSR), and an hourly rate of \$400.00 for any additional consulting services described in this Agreement. The Maximum Compensation payable under this Agreement shall not exceed \$56,000.00. Contractor shall not be entitled to payment or reimbursement for any tasks or services performed except as specified herein. Contractor shall have no claim against County for payment of any compensation or reimbursement, of any kind whatsoever, for any service provided by Contractor after the expiration or other termination of this Agreement. Contractor shall not be paid any amount in excess of the Maximum Compensation amount set forth above, and Contractor agrees that County has no obligation, whatsoever, to compensate or reimburse Contractor for any expenses, direct or indirect costs, expenditures, or charges of any nature by Contractor that exceed the Maximum Compensation amount set forth above. Should Contractor receive any such payment it shall immediately notify County and shall immediately repay all such funds to

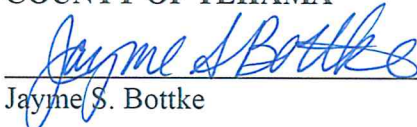
County. This provision shall survive the expiration or other termination of this Agreement.
