**RESOLUTION VACATING A PORTION OF FARQUHAR ROAD (COUNTY ROAD NO. 472), APPROXIMATELY 0.09 MILES OF ROAD EASEMENT STARTING FROM THE INTERSECTION WITH BOWMAN ROAD THENCE HEADING NORTH TO THE NORTHERLY SECTION LINE OF SECTION 33 AND 34, TOWNSHIP 29 NORTH, RANGE 5 WEST.**

**WHEREAS**, the Tehama County Board of Supervisors, by Resolution No. 2025-30 has declared its intention to consider whether or not to vacate a portion of the public easement on Farquhar Road (County Road No. 472), a public and County maintained road easement, under the provisions of the Public Streets, Highways and Service Easements Vacation Law, Chapter 3 (commencing with Section 8320), of the Streets and Highways Code of the State of California; and

**WHEREAS** notice of said intention were posted along said roadway and published in a newspaper of general circulation; and

**WHEREAS**, a public hearing was held and said portion of Farquhar Road proposed for vacation was found to be unnecessary for present or prospective public use.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors that the public easement in said Farquhar Road, described as:

Farquhar Road is located off of Bowman Road approximately 7.6 miles west of Interstate I-5. Farquhar Road heads northerly from Bowman Road to the northerly Section line of Section 33 and 34, Township 29 North, Range 5 West and more particularly shown in Exhibits A, Attached hereto and made a part hereof.

**RESERVING THEREFROM**, pursuant to the provisions of Section 8340 of the Streets and Highways Code, and for the benefit of Pacific Gas and Electric Company and AT&T California or their successors, the permanent easement and right at any time and from time to time, to install, construct, reconstruct, maintain, operate, replace, remove, repair, or renew lines of wires, poles, and other structures, equipment and fixtures above ground for the operation of said facilities in said road and including access to protect such facilities from all hazards in, upon, over, or adjacent to said easement.
