

AMENDMENT NO. 3
TO THE AGREEMENT BETWEEN THE COUNTY OF
TEHAMA AND DOKKEN ENGINEERING

The Road Agreement Number 2022-13 dated July 20, 2022 was entered into between the County of Tehama, through its Department of Public Works, (COUNTY) and Dokken Engineering (CONSULTANT), for the purpose of providing on-call environmental services and which was amended with Amendment No. 1, dated September 28, 2022 (Road Agreement Number 2022-15), and Amendment No. 2, dated January 12, 2023 (Road Agreement 2023-1) (Collectively the original agreement and Amendment nos. 1 and 2 are referred to as "AGREEMENT").

Per ARTICLE XXI CHANGE IN TERMS, of the AGREEMENT said agreement is hereby amended as follows:

ARTICLE V ALLOWABLE COSTS AND PAYMENTS

- Q. The total amount payable by LOCAL AGENCY for all Task Orders resulting from this AGREEMENT is to provide for an increase in the compensation in the amount of \$400,000. In no event shall the maximum compensation under this agreement exceed \$900,000. It is understood and agreed that there is no guarantee, either expressed or implied, that this dollar amount will be authorized under this AGREEMENT through Task Orders.


All other terms, conditions, and provisions of the AGREEMENT shall remain unchanged.

This AGREEMENT and Amendment No. 3 (Collectively referred to as the "Modified Agreement"), constitutes the entire agreement of the parties and supersedes all previous agreements, writings, and oral statements. In the event of any inconsistency or conflict between this Amendment No. 3 and the AGREEMENT, the provisions of this Amendment No. 3 shall prevail over those of the AGREEMENT. This Modified Agreement may not be further modified except in writing signed by both parties pursuant to Article XXI.




