

**ORDINANCE NO. \_\_\_\_\_**

**AN URGENCY ORDINANCE OF THE BOARD OF SUPERVISORS  
OF THE COUNTY OF TEHAMA DESIGNATING THE NEWVILLE ROAD AT STONEY  
CREEK BRIDGE AS A ONE LANE BRIDGE, AND ESTABLISHING THE MAXIMUM  
SPEED ON SAID BRIDGE AND ITS APPROACHES**

THE BOARD OF SUPERVISORS OF THE COUNTY OF TEHAMA ORDAINS AS  
FOLLOWS:

**SECTION 1.** The Board of Supervisors of the County of Tehama, by four-fifths  
vote, hereby finds and declares the following:

- (A) Ordinance No. 1947 changed the speed and weight limit of Jellys Ferry Road at the Sacramento River Bridge and made it one way;
- (B) Since that time, Jellys Ferry Road at the Sacramento River Bridge has been replaced and there is no longer a need for the ordinance since the facility that it referred to no longer exists;
- (C) The Newville Road at Kendrick Creek (also known as the North Fork of Stoney Creek) Bridge (Co. Bridge No. 08C0175 (the "Bridge") is a County bridge under the jurisdiction of the County of Tehama;
- (D) Tehama County Public Works closed the Bridge at Newville Road and Kendrick Creek (also known as the North Fork Stoney Creek) after findings of deficiency by a Caltrans inspection with the Board adopted an Emergency Proclamation on September 16, 2025;
- (E) Upon review of the Newville Engineering Plans Engineering Plans, the County finds the newly installed temporary bridge has certified by the County Engineer to bear the legal vehicle loads;
- (F) In accordance with the Speed Reduction Determination, establishment of a permanent prima facie speed limit of 25 miles per hour for the approaches to the Bridge and 5 miles per hour for the Bridge and designation of the Bridge as a one-lane bridge will adequately address roadway alignment geometric constraints;
- (G) Adoption of the foregoing measures immediately is necessary for the immediate preservation of the public health and safety, as set forth in Government Code section 25123, subdivision (d), because the temporary nature of the Bridge presents an imminent and continuing hazard to the travelling public unless and until these measures are implemented.

**SECTION 2.** Section 11.05.010 of the Tehama County Code is hereby amended to  
read:

11.05.010     Newville Road at Kendrick Creek Bridge (Co. Bridge No. 08C0175.

A.     Pursuant to Vehicle Code sections 22403 and 22404, the prima facie speed limit for the Newville Road at Kendrick Creek Bridge (Co. Bridge No.

08C0175) is hereby determined and declared to be five (5) miles per hour for all vehicles;

B. Pursuant to Vehicle Code section 22358, the prima facie speed limit for all approaches to the Newville Road at Kendrick Creek Bridge (Co. Bridge No. 08C0175) are hereby determined and declared to be twenty-five (25) miles per hour for all vehicles.

C. Pursuant to Vehicle Code section 21657, the Newville Road at Kendrick Creek Bridge (Co. Bridge No. 08C0175) is hereby designated a one-lane bridge. Vehicular traffic on said Bridge shall proceed in only one direction at any given time, as indicated by the signs erected by the Director of Public Works.

D. The Director of Public Works shall promptly erect suitable signs in accordance with Vehicle Code sections 21657 and 22404.

**SECTION 3.** This Ordinance is an urgency ordinance necessary for the immediate preservation of public health and safety. Pursuant to Government Code section 25123, subdivision (d), this ordinance shall take effect immediately upon adoption by four-fifths of the Board of Supervisors, and prior to the expiration of fifteen (15) days from the adoption thereof shall be published at least one time in the *Red Bluff Daily News*, a newspaper of general circulation in Tehama County.
