RESOLUTION OF THE BOARD OF DIRECTORS OF THE SKY VIEW COUNTY WATER DISTRICT (SVCWD), COUNTY OF TEHAMA, STATE OF CALIFORNIA IN THE MATTER OF:

ADOPTION OF CONFLICT OF INTEREST CODE

At the October 15th special meeting of the Board of Directors of the Sky View County Water District (the 'District), it was motioned by Director $\frac{D_1 \times D_2}{D_1 \times D_2}$ and duly carried that the following resolution be adopted.

WHEREAS, the Sky View County Water District is a duly established County Water District authorized pursuant to California Water Code Section 30320, to supply water to the community located in Tehama County known as the Sky View County Water District; and

WHEREAS, section 87300 of the California Government Code requires every public agency to adopt and promulgate a Conflict of Interest code; and

WHEREAS, amendments to the Political Reform Act, Government Code Sections 81000 have in the past and foreseeably will in the future require conforming amendments to be made in Conflict of Interest Codes adopted pursuant to its provisions; and

WHEREAS, the Fair Political Practices commission has adopted a regulation, 2 Cal. Code of Regs, Section 18730, which contains the terms of a standard model Conflict of Interest Code, which can be incorporated by reference, and which will be amended to conform to amendments in the Political Reform Act after public notice and hearings conducted by the Fair Political Practices Commission pursuant to the Administrative Procedure Act, Government Code Sections 11370; and

WHEREAS, 81 1990 Government Code Section 87306.5 was added to the Political Reform Act requiring every local agency which has adopted a Conflict of Interest Code to review its code every two years and updating if necessary; and

WHEREAS, The District reviewed its Conflict of Interest Code in compliance with the Political Reform Act at a special meeting held on October 15, 2025, by and through Resolution 25-002.

WHEREAS, section 82011 of the California Government Code requires that the reviewing body for agencies located entirely within the county shall be the County Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED and the Board of Directors of the Sky View County Water District hereby finds that:

1. The Conflict of Interest Code is adopted pursuant to the provisions and in accordance with the requirements of sections 87300 of the California Government Code.

2. After adoption of this Resolution the Secretary of the Board of Directors of Sky View County Water District shall forward a certified copy of this resolution with appendices to the Tehama County Board of Supervisors for review and approval and/or amendment.

CONFLICT OF INTEREST CODE FOR THE SKY VIEW COUNTY WATER DISTRICT

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations Sec 18730) that contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearing it may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendix designating positions and establishing disclosure categories, shall constitute the conflict of interest code of the SKY VIEW COUNTY WATER DISTRICT.

Individuals holding designated positions, as shown in Appendix A, shall file their statements of economic interest annually with the SKY VIEW COUNTY WATER DISTRICT who will make the statements available for public inspection and reproduction.

(Gov. Code Section 81008). Statements for all designated positions will be retained by the SKY VIEW COUNTY WATER DISTRICT.

APPENDIX A

Designated Positions

Designated Positions General Manager Board of Directors Consultants / New positions* Disclosure Categories (Appendix B) 1,2 **

* The General Manager may determine in writing that a particular consultant or new position, although a "designated position," is hired to perform a range of duties that is limited in scope and thus is not required to fully comply with the disclosure requirements described in this section. Such written determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements.

The determination is a public record and shall be retained for public inspection in the same manner and location as this Conflict of Interest Code.

Officials Who Manage Public Investments

It has been determined that the following positions manage public investments and will file a Statement of Economic Interest pursuant to Government code Section 87200 (Statutory Filers):

- Members of the Board of Directors

An individual holding one of the above listed positions may contact the Fair Political Practices Commission for assistance or written advice regarding their filing obligations if they believe that their position has been categorized incorrectly. The Fair Political Practices Commission makes the final determination whether a position is covered by Government Code Section 87200.

APPENDIX B

Disclosure Categories

Category 1

Interests in real property located within the current boundaries of the Sky View County Water District or within two miles the boundaries of the District or within two miles of any lands owned or used by the District as well as investments and business positions in business entities, and income, including receipt of loans, gifts and travel payment from sources that provide real estate services (e.g. consulting, appraisal, development, construction) of the type used by the District.

Category 2

Investments and business position in business entities, and income, including receipt of loans, gifts, and travel payment, from sources that provide services, supplies, materials, machinery, or equipment of the type utilized by the District. Sources may include, but are not limited to engineering and environmental consulting firms, water and soil testing companies, products and services contractors, mechanical vendors, farmers, and their agents.
