

## REINSTATEMENT AND TERM EXTENSION AGREEMENT

### Shelter Services Agreement (UC Davis Agreement #A71318/UCDPO00264758)

This Reinstatement and Term Extension Agreement ("Reinstatement Agreement") is entered into as of \_\_\_\_\_, 2026 ("Effective Date"), by and between THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, on behalf of its Davis Campus School of Veterinary Medicine and Koret Shelter Medicine Program ("University"), and TEHAMA COUNTY ANIMAL SERVICES ("Shelter").

#### RECITALS

- A. University and Shelter previously entered into that certain Shelter Services Agreement, identified as UC Davis Agreement #A71318, effective December 15, 2022 ("Original Agreement").
- B. The Original Agreement was amended by a First Amendment (together with the Original Agreement, the "Agreement").
- C. The term of the Agreement expired on April 14, 2026, and the parties desire to reinstate the Agreement and continue their contractual relationship.
- D. The parties further desire to extend the term of the Agreement, subject to the terms and conditions set forth herein.

**NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties agree as follows:**

#### **1. Reinstatement.**

Effective as of the Effective Date, the Agreement is hereby reinstated in full force and effect, as if it had never expired, subject to the modifications expressly set forth in this Reinstatement Agreement.

#### **2. Extension of Term.**

Section 3 ("Term") of the Agreement is hereby amended and restated to read as follows:

"Term. Services shall be rendered from the Effective Date of this Reinstatement Agreement through December 31, 2026, unless earlier terminated in accordance with the terms of the Agreement."

#### **3. No Other Modifications.**

Except as expressly provided in this Reinstatement Agreement, all terms, conditions, representations, warranties, and obligations of the Agreement remain unchanged and in full force and effect. In the event of a conflict between this Reinstatement Agreement and the Agreement, this Reinstatement Agreement shall control.

**4. Authority.**

Each party represents and warrants that it has the full right, power, and authority to enter into this Reinstatement Agreement and to perform its obligations hereunder.

**5. Counterparts.**

This Reinstatement Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument. Electronic signatures shall be deemed original signatures.
