NOTICE OF APPROPRIATION LIMITATION DOCUMENT 2024-25 AND 2025-26 FISCAL YEARS

NOTICE IS HEREBY GIVEN that the Appropriation Limitation Document for Tehama County for the 2024-25 and 2025-26 fiscal years has been prepared and is available for public inspection at the Office of the Clerk of the Board of Supervisors, County Courthouse, Room 12, Red Bluff, or the Office of the County Auditor, 444 Oak Street, Room J, Red Bluff.

The document finds that Tehama County's appropriation limit for Fiscal Year 2024-25 was \$77,124,234. It has also been determined that of the County's 2024-25 appropriations and provisions for reserves of \$221,653,021 the amount of \$36,746,453 was subject to the limitation and is, therefore, \$40,377,781 under the limitation.

The estimated appropriation limit for Fiscal Year 2025-26 is \$81,754,461.

The Appropriations Limits will be reviewed and adopted by the Tehama County Board of Supervisors on September 23, 2025 at the board meeting which begins at 9:00 a.m. The meeting is held at 727 Oak Street in the Board of Supervisors Chambers.
