# AMENDMENT NO. 4

## TO THE AGREEMENT BETWEEN THE COUNTY OF TEHAMA AND DOKKEN ENGINEERING

The Road Agreement Number 2022-13 dated July 20, 2022, was entered into between the County of Tehama, through its Department of Public Works, (COUNTY) and Dokken Engineering (CONSULTANT), for the purpose of providing on-call environmental services and which was amended with Amendment No. 1, dated September 28, 2022,(Road Agreement # 2022-15), Amendment No. 2, dated January 12, 2023,(Road Agreement #2023-1), and Amendment No. 3, dated March 26, 2024,(Road Agreement #2024-004) (Collectively the original agreement and Amendment Nos. 1 through 3 are referred to as " the AGREEMENT").

Per ARTICLE XXI CHANGE IN TERMS, of the AGREEMENT said agreement is hereby amended as follows:

### ARTICLE I INTRODUCTION

A. This AGREEMENT is between the following named, hereinafter referred to as, CONSULTANT and the following named, hereinafter referred to as, LOCAL AGENCY:

The name of the "CONSULTANT" is as follows: Dokken Engineering Incorporated in the State of California The Project Manager for the "CONSULTANT" will be Sarah Holm. The name of the "LOCAL AGENCY" is as follows: Tehama County, through its Department of Public Works

The Contract Administrator for LOCAL AGENCY will be the Director of Public Works.

### **ARTICLE IV PERFORMANCE PERIOD**

A. This agreement shall go into effect on July 19, 2022, contingent on approval by LOCAL AGENCY. CONSULTANT shall commence work after notification to proceed by LOCAL AGENCY's Contract Administrator. The AGREEMENT shall end July 31, 2027, unless terminated in accordance with ARTICLE VI below.

#### ARTICLE XXXIII NOTIFICATION

This AGREEMENT and Amendment No. 4 (Collectively referred to as the "Modified Agreement"), constitutes the entire agreement of the parties and supersedes all previous agreements, writings, and oral statements. In the event of any inconsistency or conflict between this Amendment No. 4 and the AGREEMENT, the provisions of this Amendment No. 4 shall prevail over those of the AGREEMENT. This Modified Agreement may not be further modified except in writing signed by both parties pursuant to Article XXI.
