Title III Project Proposal Resource Conservation District of Tehama County Community Defensible Space Program

The Resource Conservation District of Tehama County (RCDTC) is requesting **\$25,445.14.** from Tehama County's Title III funding to help bolster the RCDTC's defensible space assistance (DSA) and wildfire prevention through the TinderSmart Tehama program. DSA has been hugely popular with and helpful to the residents of Tehama County.

One of the successes of the program has been leveraging both State and Federal funding for wildfire mitigation in Tehama County. In the past, the RCDTC has leveraged Title III funding in the development of millions of dollars in project work for the residents of Tehama County. This work includes TinderSmart wildfire prevention within Tehama County including Tehama DSA, roadside fuel reduction services, and forest health grants on both the east and west sides of Tehama County.

As residents of Tehama County are engaging more in wildfire preparedness within their communities to develop Fire Safe Councils and Firewise Communities, the RCDTC is requesting \$25,445.14. to continue to serve the community. The funding will be broken out into two, which consist of the following:

- 1. Continue to support grant writing and the Tehama-Glenn Fire Safe Council. The RCDTC will continue to utilize the funding to seek project ideas from community groups and write additional grants that benefit Tehama County. This year's request is **\$5,000.00**.
- 2. Further development of ingress and egress evacuation routes in Tehama County. The request is for **\$20,445.14** in Title III funds which will leverage three \$99,000.00 grants from PG&E for ingress/egress fuels reduction along county roads in Tehama County. The aim is to reduce fuels load to lower susceptibility to high intensity wildfire and increase ingress/egress for community members and emergency personnel. The work is to be completed via hand crew or mastication.
